CERTIFICATE OF FIRST AMENDMENT TO THIRD AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR HILL FARM

WHEREAS, the Third Amended and Restated Declaration of Covenants, Conditions and Restrictions for Hill Farm (the "Declaration") was recorded on April 19, 2010, Sequence 20100740475, office of the Pima County Recorder; and

WHEREAS, pursuant to A.R.S. §33-1817 and Section 11.2.3 of the Declaration, the Declaration may be amended by the written consent of 51% of the Lot Owners; and

WHEREAS, the Lot Owners have met the requirements to amend the Declaration.

NOW, THEREFORE, the Declaration is amended as follows:

1. The following provision is added to Article VIII, Section 8.9:

Section 8.9.5. <u>Minimum Rental Term</u>. Dwelling units may not be leased for an initial term of less than six (6) consecutive months.

All other provisions of the Declaration shall remain in full force and effect.

IN WITNESS WHEREOF, the undersigned certify that at least 51% of the Lot Owners in Hill Farm approved this First Amendment to the Declaration by written consent.
